Dr. Swagger -3.5% cost of living increase, and loan payoffs new to budget. College is able to accomplish more this fiscal year due to CARES Act and other COVID related funding.

Various positions filled using COVID funding. Directors are aware they'll need to support the positions in 2 years once COVID funding is done.
