Financial Aid has also been working on communicating with our bachelor graduates to ensure that they are aware of the scholarship opportunities for graduates if they plan to continue on for their master's degree.

Ellucian Update:

Business Office had our live simulation last week and things went well with the accounts receivable module. We tested a variety of student types and billing to make sure everything is working right. Just a few things related to billing will need to be fixed and tested again later. We plan to go live with accounts receivable in July. We will need to work on getting our student account balances over to the new system.
